St. Louis City Traffic Stop Policy

There is an ongoing St. Louis Police Department policy current going on with traffic stops that any firearms in the vehicle are confiscated.

The process to recover your lawfully owned property is to present proof of ownership, form 4473 or sales receipt. What happens to the gun if it was a gift from uncle Bob who is long dead? If you are a city resident you are referred to the St. Louis Sheriff's Department to process this recovery. We have contacted the St. Louis Sheriff's Department's Sheriff Vernon Betts to find out if he is aware that his office is being entangled in this issue of recovery. Sheriff Vernon Betts was not aware of this issue or who is processing this in his office. Sheriff Vernon Betts was very thankful for us bringing this to

his attention.

Mayor Lyda Krewson and Public Safety Director Jimmie Edwards do not care much for the Sheriff and his department or his strong support for Missouri concealed carry that he issues in St. Louis City. Sheriff Betts first reply to me was that this is illegal and disturbed that his department is being entangled in this activity.

The best way to avoid any loss of legally owned firearms is to maintain a concealed carry endorsement which verifies that you are a good guy. These rotten politicians are doing everything possible to nullify Missouri's Constitutional Carry Law.

Missouri Legislators Speak at October Members' Meeting

At our October Members' meeting guest speakers Dottie Bailey, Representative for the 110th District and Jim Murphy, Representative for the 94th District came in and did an excellent review of upcoming legislation and items of concern.

Discussion topics covered were:

- Social Justice Reform for Veterans.
- Red Flag bills.
- various other bills
- Issues with Republicans In Name Only and how some are just caving in on gun rights issues.
- That various officials are now out right calling for gun confiscation with no Due Process.

During Q & A the topics covered were:

- Support for Law Enforcement and not cracking down on the law abiding for the actions of a few.
- The Second Amendment Preservation Act
- POPing, Proof of Purchase tactics by police to confiscate legal guns from people during a traffic stop.
- The Clean Missouri Amendment, how it is bad and that it needs to go.
- The need for grass root support for campaigns and gun rights issues.



A New Candidate for Confiscator-in-Chief

Former Texas Congressman Robert Francis O'Rourke abandoned his run for President last week, once again leaving a void for the most strident anti-gun candidate seeking the Democrat nomination. Even before declaring his candidacy for President, California Representative Eric Swalwell raised the specter of banning AR-15s and similar firearms, forcing Americans to turn them in through a confiscation scheme mislabeled as a "mandatory buyback," then "go[ing] after" resisters. He even famously "joked" about using nukes to enforce his scheme.

After Swalwell became the first candidate to bow out of the race when he failed to generate any noticeable poll numbers, O'Rourke stepped up to push the confiscation message.

Clearly, every Democrat that wants to run against Trump is

anti-gun. The main difference among them, when it comes to semi-automatics, seems to be whether they want to ban their future production, ban them completely and confiscate them, or ban their future production and register those currently owned (presumably to make future confiscation easier).

But, with multiple sources now reporting that anti-gun billionaire Michael Bloomberg is once again considering throwing his name into the already crowded Democrat field, it's likely that anti-gun extremists won't have to wait long for a new champion of confiscation. After all, he'll be the only candidate who can tout his experience as a firearm confiscator.

- Red Flag gun confiscations
- Ban on high-capacity ammunition magazines
- Prohibiting those guilty of political incorrectness to own firearms

NASCAR Takes a Hard Left

After decades of NASCAR drivers literally turning left for hours every race day (road course races excluded, of course), the governing body appears to be taking a figurative left turn, politically.

K-Var, a retailer in outdoor and shooting sports products, reports that it was told it would need to edit/change an ad submitted earlier this year it had intended to be included in NASCAR's official program. The problem, apparently, is that the K-Var ad included depictions of "assault-style rifles/sniper rifles." Presumably, the offending firearm is an AK-variant manufactured by Arsenal.

NASCAR's official media sales agent told K-Var (as well as other potential advertisers), that the racing organization is undergoing a "gradual shift in (its) position on guns," which would appear to include NASCAR determining it is now opposed to the lawful manufacture, sale, and/or possession of what it refers to as "assault-style rifles/sniper rifles." Or, at least, the organization is opposed to advertising such items.

This seems to follow a trend of head-scratching corporate decisions to alienate a significant percentage of current and potential customers .

SCOTUS Remington Decision

The Supreme Court has ruled that a lawsuit against gun maker Remington and its marketing practices filed by parents of victims of the Sandy Hook massacre can proceed.

While the lawsuit itself can proceed, there's no guarantee of victory for the plaintiffs. Also note that the Protection of Lawful Commerce in Arms Act isn't implicated in the Supreme Court decision. Instead, the lawsuit relies on a state consumer protection law, which is why the plaintiffs now have to try to prove that Remington's advertising actually caused a murder.

Gun control groups, meanwhile, are still celebrating the news that the lawsuit can continue.

This isn't about "reforming" the firearms industry, as the Brady Campaign claims. It's about bankrupting gun makers and trying to force them out of business. Donald Verilli, the Obama-era Solicitor General who's now representing several families in their lawsuit against Remington, has been a longtime opponent of the right to keep and bear arms, and previously argued before the Supreme Court in a 2011 case that the Second Amendment should be treated as a second-class right.

The issue of what level of judicial review is appropriate to Second Amendment challenges is likely to be decided by SCOTUS in the NYSPRA v. New York City case, which will be heard by the justices in early December. The outcome likely won't make much of a difference in the lawsuit against Remington, but it could thwart gun control activists from passing some of their ideal anti-gun bills. In the meantime, they'll continue to pursue any avenue possible to attack the right to keep and bear arms, including attempts to sue the firearms industry into oblivion .

CCRKBA Declares Democrats Have 'Hidden AgendaBehind Impeachment'

BELLEVUE, WA – The Citizens Committee for the Right to Keep and Bear Arms today declared there is a "hidden agenda" behind the impeachment efforts of House Democrats led by Nancy Pelosi and it is designed to tie up the U.S. Senate and derail efforts to confirm more pro-Second Amendment judges to the federal courts.

"It is clear to us that Capitol Hill anti-gunners are doing everything in their power to prevent confirmation of conservative judges who will adhere to the Constitution," said CCRKBA Chairman Alan Gottlieb. "By burdening the Senate with this nonsense, Democrats believe they can prevent confirmation of pro-Second Amendment judicial nominees during the final year of President Donald Trump's first term."

Gottlieb noted that the president is fulfilling perhaps his most important campaign pledge, which was to bring balance back to the federal courts. Restoring that balance could be the president's greatest legacy, he said.

"The same people pushing impeachment have been staunch allies of the gun prohibition lobby," Gottlieb observed. "Anti-

gunners have been horrified since Day One of Donald Trump's presidency that he was actually determined to rein in the activist federal court system by nominating judges who understand there are ten amendments in the Bill of Rights, and that the Second Amendment really means what it says.

"More than eleven years after the landmark 2008 Heller ruling and more than nine years after the 2010 McDonald decision," he continued, "some courts still act as though neither of those Supreme Court rulings existed. But the president has been filling court vacancies with solid, intelligent jurists who understand the difference between regulated privileges and constitutionally-enumerated, fundamental rights. Capitol Hill anti-gunners and their gun prohibitionist friends can't stand it, and they're using the impeachment crusade as a smoke screen to distract the Senate from doing its duty.

"This isn't about impeaching the president," Gottlieb stated. "This is about impeaching our Second Amendment rights. I guarantee that American gun owners are going to remember this in 2020."


