Spring time 2022 is going to be primary election time here in Missouri. There are several pro-gun candidates for state level offices. Try to learn where they stand on the important issues.

The big issue now is the suit filed by St. Louis City, St. Louis County, Jackson County and Green County to contest the Second Amendment Preservation Act (SAPA). The parties bringing this suit probably haven't even read the SAPA act and what it contains. The principal of the act is to prevent state level law enforcement from participating with any federal government agency enforcing acts that over reach on our Second Amendment rights here in Missouri.

The Maricopa County Sheriff in Arizona was enforcing the laws against illegal aliens on the federal level. The federal government judge for that district directed him to cease and desist because he had no authority to enforce federal law. This sounds like precedence on state law enforcement from enforcing federal laws. Prohibiting sheriff and local law enforcement agencies with this directive. You certainly can't have it both ways. I hope that this gets resolved to the Missouri residents gun owners benefit.

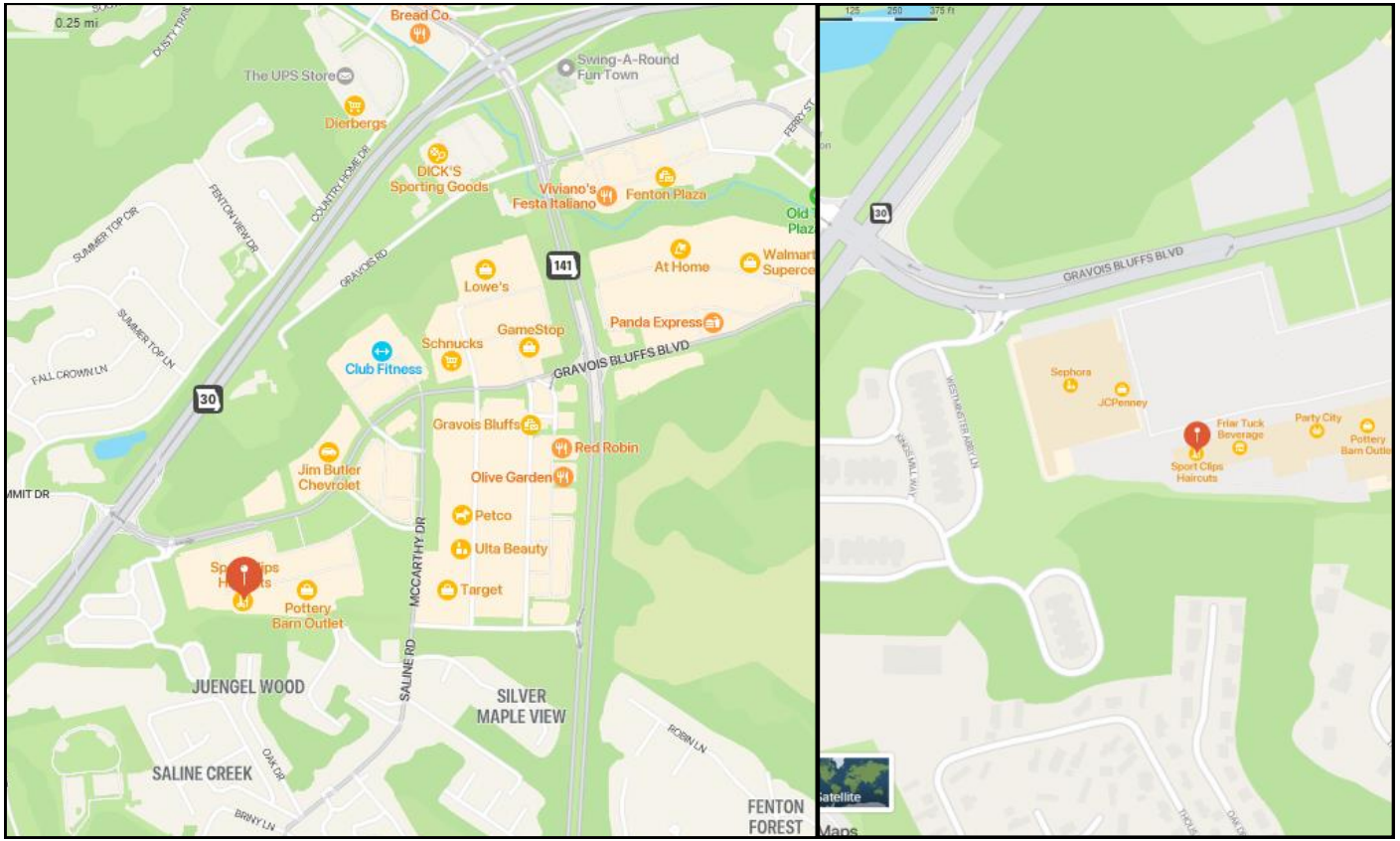
GCLA-PAC

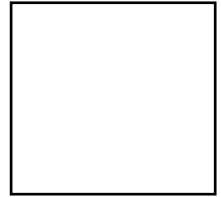
