Spring has finally arrived in Missouri. The time of year when the Missouri House and Senate are in full swing. HB1080 was introduced

This bill would have allowed an individual with a valid concealed carry permit to possess a firearm on any publicly funded transportation system, including systems providing bus or train service.

A permit holder may not be harassed or detained for carrying a concealed firearm on the property of the transportation system and may not be prohibited from acting in self defense or defense of others, while on the property of the transportation system.

Senate Bill 529 was practically the same wording.

This is so important. Thank you to those that wrote and called their Senator and House Representative in Jefferson City. GCLA will encourage this legislation to be introduced again next year. Your personal safety and civil liberties are important.

Once again the NRA Annual Meeting was a remarkable success. Held in Nashville Tennessee, there was record attendance at over 73,000. As in past meetings several GCLA members worked and attended to make it successful. In 2016 the NRA Annual Meeting will be in Louisville, Kentucky.

To be mindful that all who were there were able to carry their personal safety will them and of course the result was the same as in the previous annual meetings, a very well behaved group with a bunch of bored security people.

## Missouri Update

During the Missouri 2015 Legislative Session, Governor Jay Nixon (D) signed numerous budget bills that included budgetary line items relating to school safety and security measures. Along with active shooter training and other measures already in place, these items address the issue of creating a safer school environment by making Missouri more compliant with the NRA's National School Shield Program.

## Judge Halts DC's Rule Requiring Justification for 2A Rights

The courts may have forced the District of Columbia to recognize its citizens' right to keep and bear arms, but the city did all it could to restrict the number of firearms. When journalist Emily Miller tried to get a gun in February, she was told she was only the 16th person the city deemed had a "good reason" to carry a handgun — probably because she was a journalist writing about the topic. On Monday May 18th, the U.S. District Court for the District of Columbia ordered the city to stop enforcing the rule making citizens justify their rights, saying it violated the Second Amendment. "The District of Columbia's arbitrary

'good reason'/proper reason' requirement ... goes far beyond establishing such reasonable restrictions," the court wrote in the ruling. "Rather, for all intents and purposes, this requirement makes it impossible for the overwhelming majority of law-abiding citizens to obtain licenses to carry handguns in public for self-defense, thereby depriving them of their Second Amendment right to bear arms." The fight's not over, though. The city is expected to appeal, and the issue of DC's gun laws could end up at the Supreme Court once again.

# **Supreme Court Says Convicted Felons Can Sell Their Guns**

A unanimous Supreme Court ruled that the government can't prevent a convicted felon who is barred from possessing firearms from trying to sell his guns after they are confiscated by authorities.

The justices sided with Tony Henderson, a former U.S. Border Patrol agent who agreed to turn over his collection of 19 firearms to the FBI as a condition of release after he was arrested and charged with distributing marijuana.

After he pleaded guilty, Henderson wanted to sell the weapons valued at more than \$3,500 to a friend, or transfer them to his wife. But lower courts found that doing so would technically give Henderson possession of the weapons in violation of the law. Prosecutors also said they were concerned that Henderson's friend or wife might give him access to the weapons.

Writing for the court, Justice Elena Kagan said letting a convicted felon sell or transfer guns is allowed as long as a court is satisfied that the person getting the weapons won't give the felon control over them.

"A felon cannot evade the strictures of (the law) by arranging a sham transfer that leaves him in effective control of his guns," Kagan said.

Kagan said the district court could have ordered the guns turned over to a federally-licensed firearms dealer, who would sell them with proceeds going to Henderson. She said the lower court also could allow Henderson to transfer the guns to another person who will not allow him "to exert any influence over their use."

She said the government's reading of the law goes too far in saying Henderson would illegally "possess" the weapons just by being allowed to sell them.

The case had drawn the attention of gun-rights groups which argued that the government's attempt to prohibit any sale or transfer prevents law-abiding citizens who want to buy the guns from doing so.

# DC loss for gun control puts New York City's laws at risk

The latest fight over gun control in Washington, DC, looks like one for New York to watch. It's on the question of whether the District of Columbia can require residents applying for pistol permits to show "good reason."

Short work was made of the question by US District Judge Frederick J. Scullin Jr. He struck down DC's requirement that gun-permit applicants provide a "good reason" to own a firearm. And he set an aggressive schedule to speedily resolve the granting of a permit to plaintiffs.

That national battle could very well come to New York City. The city's strict laws governing residents' ability to carry a concealed gun would be vulnerable to the same constitutional objection as the DC gun laws.

If Scullin's judgment were imposed on New York — either by a higher court or Congress — it would render unenforceable the city's demand that permit applicants show a good reason (usually a clear need for self-defense) before getting approved.

It's a big deal because the "good reason" hurdle is being used by municipalities to evade the Bill of Rights. What would be the reaction were Americans required to show "good reason" before they were allowed to pray in public, speak on a street corner, publish or read newspapers, to see a search warrant or to remain silent when arrested.

All are protected under the Bill of Rights. No questions asked.

This is an irony for New York. The most progressive state is one of the most regressive when it comes to the Second Amendment. And it's a far cry from New York's roots; the state ratified the Constitution only on the condition that it would protect the right to bear arms. It carefully marked that condition in a famous statement put out in Poughkeepsie at the time the Constitution was ratified.

It asserted that the "people have the right to keep and bear arms." It said nothing about them having to show good reason.

# **Pending National Right-to-Carry Legislation**

National Right-to-Carry bills have seen increases in cosponsorships. Please continue to contact your elected officials and urge them to cosponsor and support these important bills:

S. 498 - Introduced by U.S. Senator John Cornyn (R-Texas), this legislation would respect the rights of individuals who possess concealed carry permits from their home state, or who are not prohibited from carrying concealed in their home state, to exercise those rights in any other state that does not prohibit concealed carry. This bill currently has 27 cosponsors.

H.R. 923 - Introduced by U.S. Representative Marlin Stutzman (R-Ind.), this legislation is the House companion bill to S. 498. The legislation would also respect the rights of individuals who possess concealed carry permits from their home state, or who are not prohibited from carrying concealed in their home state, to exercise those rights in any other state that does not prohibit concealed carry. This

bill currently has 29 cosponsors.

H.R. 986 - Introduced by U.S. Representative Richard Hudson (R-N.C.), this bill would allow any person with a valid carry permit or license issued by a state to carry a concealed firearm in any other state that does not prohibit concealed carry. This bill would also provide legal protection for law-abiding concealed carry permit holders against states that violate the intent of this bill. This bill currently has 151 cosponsors.

H.R. 402 - Introduced by U.S. Representative Rich Nugent (R-Fla.), this bill would allow any person with a valid carry permit or license issued by a state to carry a concealed firearm in any other state that does not prohibit concealed carry. The bill currently has 88 cosponsors.

### **Arnold Junior Shooters Pistol Team**

The Scholastic Pistol Program, Midwest Regional Championship was held Friday April 17th and Saturday April 18th, 2015, at the World Shooting and Recreational Complex in Sparta, IL. The Pistol Team competed in two divisions within the Junior Class (12-16 years old): Junior Rim-Fire and Junior Center-Fire. There were four individual recognition awards given for top performances.

The AJS Pistol Team took three of the four individual awards, as well as the Gold in each division in which they entered. These First Place wins included Gold Medals, with top prize money to be deposited into the team's Midway USA Endowment. (The Midway USA Endowment account allows each team to spend 5% per year of deposited funds.)

These latest wins are the fifth and sixth Regional Championship wins since 2013, with four Midwest Regional Championship wins, and two Southeast Regional Championship wins (Kentucky in 2013, and Tennessee in 2014), with Second Place (Silver Medal) wins in the 2013 and 2014 in the Midwest Regional Championship.

The National Championships will be this July 13-18, 2015 at the World Shooting and Recreational Complex in Sparta, IL. The AJS Pistol Team will be the defending champions in the Junior Rimfire division and will be seeking a gold in one or more divisions. Approximately 40 teams from all over the country complete in each division. Last year it was announced that this was the largest Youth Action Pistol Event ever held in the United States.

The AJS Pistol Team has had four wins at the National Championships in two years (2013 and 2014). One (Gold Medal) First Place win in each year as well as a (Silver Medal) Second Place win in 2013, and a (Bronze Medal) Third Place win in 2014. In our first competition (a regional competition in 2013) the team won a Silver Medal, but then brought home one or more Gold Medals from each of the next seven competitions, to bring the total to 9 Gold Medals, 4 Silver Medals, and 2 Bronze Medals.

Last August was the first SPP Missouri State Championship (at the COPS range outside of Rolla, MO). The AJS Pistol Team won First Place (Gold Medal), Second Place (Silver Medal) and Third Place (Bronze Medal), taking all the individual high honors, and all of the prize money (again, to be deposited into the Midway USA Endowment Fund account).


